Death Valley Unified held a public hearing on September 14, 2020, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams VS. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption'. ## School Facility Conditions and Planned Improvements

Tecopa-Francis Elementary was originally constructed in 1963 and is comprised of 3 classrooms a multipurpose room/cafeteria, and a large playground.

**Cleaning Process:** The principal works with the custodian to ensure that the school is kept clean and safe. **Maintenance and Repair:** District maintenance staff ensures that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner.

**Deferred Maintenance Budget** The district participates in the State School Deferred Maintenance Program, which provides matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components.
